Welby should have resigned long before he did

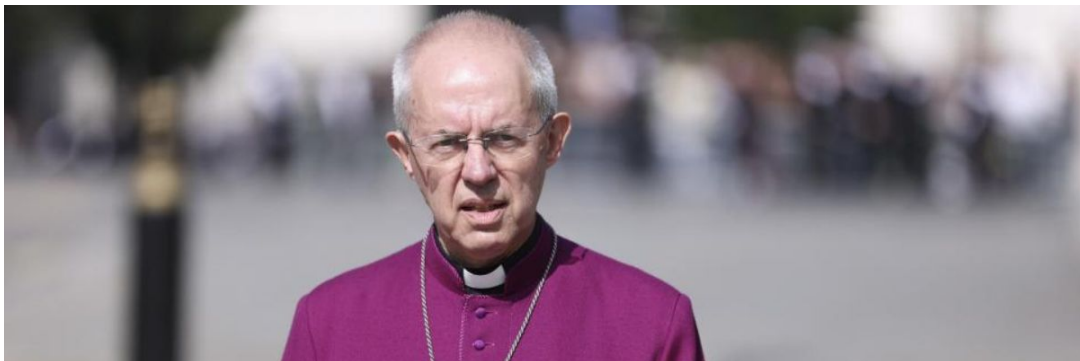
This week, the Archbishop of Canterbury stepped down after widespread calls for him to resign over his part in the failure to expose abuse within the Church of England (CofE).

Chaplain hands in 40,000 petition to CofE

Rev. Dr Bernard Randall, supported by the Christian Legal Centre, is seeking justice after a senior Church legal officer for clergy discipline found that the Archbishop of Canterbury 'misunderstood the scope of his powers', and was 'plainly wrong' for blocking a serious complaint of misconduct being investigated.

Together with Bernard, we delivered a 40,000 signature petition to Lambeth Palace, just hours before Justin Welby announced his resignation.

Bernard commented:

'It looks as if the senior leadership of the Church of England are afraid of being openly, emphatically Christian.'

Bernard has still not received justice. Pray with us that he will be vindicated swiftly.

Assisted suicide has devastating consequences

'Assisted dying' is not removing life support. It's not writing a 'do not resuscitate' request. And it's not providing pain relief in someone's dying moments.

Communications Manager Paul Huxley discusses the manipulative language used by pro-euthanasia campaigners to disguise the grim reality of assisted suicide.

We've been sent a number of dark stories that expose how legalising assisted suicide will affect society. Holly Baines highlights these to show how legalising assisted suicide will threaten vulnerable people.

The father of the late Indi Gregory speaks from tragic experience when he says that the promised safeguards about judges in Kim Leadbeater's bill is "meaningless".

A judge ruled that it was in Indi's best interests to have her life support removed against the wishes of her family and despite the offer of further treatment in Italy at no cost to the NHS.

Nurses urge Health Secretary to protect women

The Darlington Nursing Union has urged Health Secretary Wes Streeting to issue formal guidance to NHS Trusts to ensure that changing rooms, showers or toilets may only be shared based on biological sex, not self-declared gender identity.

The union has been started by the group of nurses at Darlington Memorial Hospital, after they were infamously victimised by their bosses for complaining of harassment in their female changing room by a biological male who identifies as a woman.

Charity which harmed children 'let off lightly'

Public Policy Researcher Carys Moseley investigates whether the Charity Commission is guilty of 'whitewashing' the transgender charity Mermaids, who claimed that puberty blockers are reversible.

Sexuality

The Foundling Museum has launched an LGBT+ rendition of Handel's deeply Christian 'Messiah' – called A Queer Georgian Yuletide: Handel's Queer 'Messiah' – as part of its Queer Georgian Social Season events.

Elsewhere, at the Human Rights Council, the UK government's statement on Costa Rica advised the country to 'take further measures on banning conversion therapy'.



Education

The Daily Mail published two reports on the indoctrination of transgender ideology in school.

One article revealed that a school is telling ‘pupils aged as young as four to address their gender neutral teacher as ‘Mx’.

The other report shared of a Glasgow school facing backlash from teachers, who are concerned that parents are unaware that the school is organising a coffee morning fundraiser ‘to buy chest binders for trans pupils’.

Pray that our schools will not continue to push harmful transgender ideology on young children, that pupils will be protected from the effects of these radical ideas, and that teachers will be emboldened to speak up about the reality of what is being taught and promoted in schools.

Freedom of speech

Telegraph journalist Allison Pearson reports on the 'two-tier justice system' as police launched an investigation into a tweet she posted last year, accusing her of a non-crime hate-incident. Many have come out in opposition to this 'appalling attack on free speech', with the Daily Mail reporting on 'thought policing' and the Telegraph warning against police patrolling opinions.

Christian Legal Centre client Councillor Anthony Stevens responded to the reports by sharing his own experience of being arrested over an alleged non-crime hate-incident relating to posts he made defending free speech.

Pray that our police force would focus on preventing crime rather than controlling opinions, that our politicians would stand up for freedom of speech, and that those targeted would be protected and emboldened to continue standing for truth.

Sexuality

The Daily Mail reported that Debenhams was forced to remove an offensive 'A gay in a manger' Christmas jumper after Christians protested and boycotted the store.

Praise God that Debenhams agreed to removing this jumper mocking the message of Christmas, and pray that the true meaning of Christmas would be restored and celebrated in our nation once again.
