

Sacked for upholding Scripture at Catholic school

Last week, we revealed that Gozen Soydag, a Christian educational behavioural assistant, had launched legal action after <u>losing herjob for social media posts about marriage</u>.

This week, the <u>Daily Mail put together a small biography of Gozen's life</u>, including her coming to faith in her twenties, what led to her success on social media (see <u>@wifeinthewaiting</u> and <u>@ladygozen</u>), and her sacking for posts about marriage.

"Gozen is certainly no sackcloth and ashes Christian. In person she is lively and even (whisper it) fun."

Gozen was also <u>interviewed by Jacob Rees-Mogg on GB News</u>, where she was able to explain her experience at the school and share how her freedom of speech was being attacked because she shared biblical truths, despite her work being praised prior to the complaints.

Sudiksha's story wins journalism award

Inderdeep Bains, the Daily Mail journalist who exposed the tragic story of the late Sudiksha Thirumalesh has won a media award and a 'Highly Commended' nomination for her efforts.

Sudiksha, who was supported and whose family continues to be supported by the Christian Legal Centre, was given huge media attention and several front page headlines as people were shocked at the way doctors and judges treated this desperately ill young woman.

While Sudiksha's condition was serious, it did not affect the functioning of her brain. But as Sudiksha sought life-saving treatment rather than simply accepting that she was going to die, she was labelled 'deluded' by doctors and judges.

There are still other people in similar situations to Sudiksha who are being supported by the Christian Legal Centre (CLC). Only last week did we reveal that the <u>CLC is supporting a family who are being gagged by a transparency order</u>, and whose ill mother is being threatened to have her life support removed.

Pray for these people's wellbeing. Pray that our culture would cherish life and not adopt the attitude that it could be in some people's 'best interests' to die. Pray for Christian Concern as we continue to stand in these end-of-life cases.

Following Justin Welby's resignation, Steven Cottrell, the Archbishop of York, has now faced calls to resign this week for inaction after overlooking abuse committed by a bishop.

End of life

Kim Leadbeater MP said that her bill on legalising assisted suicide, which passed its second reading three weeks ago, represented "Parliament at its best."

But Madeline Grant responds in the Telegraph that "this may be partly because she now has the right to assemble the committee which will scrutinise the Bill. If that sounds like a recipe for a stitch-up then that's because it is."

"A rushed, unscrutinised Bill will have catastrophic consequences when its safeguards inevitably fail; consequences for which Leadbeater and her allies will be directly responsible."

Education

A bill has been put forward to Parliament proposing a register that would identify children in England who are not currently attending school, as well as increase power for local councils. The bill comes in response to the murder of 10-year-old Sara Sharif, whose father and stepmother were sentenced for her murder this week. Pray that the parliamentary reaction to the tragedy of Sara would not result in difficulties to Christian parents who are faithfully home educating their children. Independent public health consultant Kevin Duffy explains how information from the Hospital Episode Statistics reveal that <u>abortion complications rates are much worse than reported by abortion providers</u>.

A new official report acknowledges a significant gap between the numbers of abortion complications reported by abortion providers and the numbers of those being treated for these complications at NHS hospitals. The former showed only 1.5 complications per 1,000 abortions and the latter twelve times more, 18 per 1,000. But Kevin Duffy points out that if the OHID included the complications termed 'medical abortion - incomplete, without complication', the reported rate would be 45 complications per 1,000 abortions: thirty times more than current official reporting.

If the government doesn't require this annual reporting of complications, it would be responsible for the deliberate under-reporting of more than ten thousand cases of post-abortion complications treated by our NHS hospitals each year.

Pray that the truth about abortion complications would be exposed and that the government would hold abortion providers to account rather than minimising the life-threatening risks posed for the pregnant mother as well as the death of her unborn child.
